

# Legislature passes bill requiring the Department of Public Safety to publish peace officer policies and procedures

JUNEAU-On Monday, the Alaska legislature passed Senate Bill 7, sponsored by Senator Elvi Gray-Jackson, D-Anchorage, requiring the Department of Public Safety to publish current policies and procedures related to the conduct of peace officers employed or regulated by the Department. Senate Bill 7 is part of a package of legislation called Turning Pain Into Progress that stems from the national 8 Can't Wait initiative

"This is just one step to building a stronger relationship between the public and law enforcement. When we look at these policy changes, it is critical that we protect our communities and law enforcement officers equally," said Sen.

Gray-Jackson. "This, along with the other pieces of Turning Pain Into Progress, helped develop a dialogue with law enforcement agencies throughout the state and the communities they swore to protect and serve. The progression of these efforts will build better relationships and standards such as preventing the over-policing of Black, Indigenous, and People of Color communities."

Other legislative components of Turning Pain Into Progress include: SB 1 - Banning the use of chokeholds;

SB 2 - Requires de-escalation procedures and provides a duty to intervene by officers that observe other officers violating practice standards; SB 3 - Requiring a peace officer to exhaust all possible alternatives and provide an oral warning before discharging a firearm;

SB 4 - Banning shooting at moving vehicles;

· SB 46 - Requiring comprehensive reporting by officers each time they use or threaten to use force, establishes a "use of force database" for the Department of Public Safety, Department of Corrections, municipal officers, and municipal correctional officers, and requires those agencies to search the database before employing a new peace officer.

Senate Bill 7 passed the House on a vote of 29-9 and passed unanimously in the Senate on March 8, 2022. Senate Bill 7 now heads to the Governor for his signature.

# Legislation passes Senate providing State recognition of tribes

JUNEAU - On a unanimous vote, legislation codifying federal recognition of Alaska's Tribes in State law for the first time passed the Senate this week.Despite the shared values between tribes and the state that seek to ensure vibrant and healthy communities, Alaska obtained statehood during an era of federal Indian policy where the federal government sought to terminate its trust relationship with tribes, and while the federal government ultimately embraced needed change, by passing the Self Determination and Education Assistance Act in 1975, Alaska's statutory policy towards tribes is still a relic of the past.House Bill 123 does not change the state's relationship with tribes but simply affirms their status, enumerated by the federal government."Tribes have been recognized by the federal government, and by the Executive and Judicial branches of Alaska's government, but we, the Legislature, have not held up our end of the bargain and officially acknowledged tribes in state law," said Representative Tiffany Zulkosky (D Bethel). "Regardless of this, the state looks to our tribal partners to leverage significant federal resources and provide a litany of essential services to Alaskans living in remote parts of the State. HB 123 opens the door for us to simply affirm in Alaska's legal code, the special and unique relationship that exists between tribes and the federal government.""Tribes play a very important role in the identity of the State of Alaska, and it is critical that the state finally formally recognize that," said Senator Lyman Hoffman (D - Bethel).Upon concurrence by the House, HB 123 heads to the Governor for signature.
