# Strait Science: Watch the ice go by

Andy Mahoney, from the Geophysical Institute at the University of Alaska Fairbanks gave a Strait Science presentation last week on his work on sea ice radar. Nome will be getting a radar device at the port this June, similar to that in Utqiagvik.

The acronym RADAR has become so ubiquitous that people forget it stands for "radio direction and ranging." Radar constructs an image by sending radio waves in a specific direction and calculating the distance when the wave hits something and bounces back. Mahoney explained that sea ice rubble fields, pressure ridges and flow edges all show up well on the radar, but that open water and smooth ice just appear as black patches. Larger ridges may also cast

shadows, so a black patch can mean many things. This is why watching the images change is so important.

Utqiagik has had western scientists tracking the sea ice through cameras on and off since the 1970s, when they used a 35mm camera to make timelapses. Now they use a 25 kW X-band marine radar made by Furuno. This device sees up to 12 miles away but is only regularly used to about seven miles. That distance can be increased by elevating the radar further. Their radar sits about 60 feet above sea level, on the bank

Having a steady stream of data about the sea ice throughout the year is important for both scientists and the community, said Mahoney. It can help understand the mechanics of how ice behaves and show trends in the formation and break-out of sea ice, all of which complements and building with traditional knowledge. He gave the example of when a large portion of the ice broke off in Utqiagvik on April 29, 2014, while whalers were still out. The weather prevented Search and Rescue from flying out, but SAR used the radar to see where the floes were headed and how quickly. Everyone made it back safely.

Now, Mahoney said, they're working on building an early warning system. By color-coding pixels in the images made by the radar based on when they last moved, they think that they can figure out events that might be a precursor to break-out. Mahoney showed images from January 23, 2022. They first detected a "flicker" on the ice at 4 a.m. Then, at 4:08 a.m., a large portion of the image lit up, meaning a large portion of sea ice had started to shift. At 4:46 a.m., they detected their first cracks in the ice, estimated to be 75-150 feet, and by 5 a.m., those cracks measured 600-2,400 feet.

Predictably, the presentation brought a lot of questions. From asking about coupling with wind data to uses detecting wave swells, the audience was eager for more. In Utqiagvik, Mahoney said, winds don't always correlate with break-out, and so monitoring the current is important, too. And yes, he thinks he can detect wave swells, which is some of his favorite research, but hadn't had the time to look at the data yet. Xand S- band radars use a different wavelength, which means they have different sensitivities, and Mahoney

said he'd love to work with other researchers, such as those studying birds, on their radars. Up north, he said, they've also realized that they were detecting caribou herds with the

One question that Mahoney wasn't able to answer, was about the differences between the sea ice in Utqiagvik and in Nome. And that's why they want to do it. "I'm really interested to see what we see," he

# UAF makes Alaska's first large drone flight from international airport

FAIRBANKS, UAF-An unmanned aircraft owned and operated by the University of Alaska Fairbanks flew from the general aviation area of Fairbanks International Airport on Sunday, a historic feat in the effort to safely incorporate such aircraft into controlled airspace.

The flight was the first civilian large drone operation from an international airport in Alaska.

Taking off from the airport's general aviation runway, the Sentry aircraft flew in a designated flight pattern used for departures, arrivals and runway approach practice. It was controlled remotely by UAF Alaska Center for Unmanned Aircraft Systems Integration personnel inside the ground control station near the far end of the airport's East Ramp.

The light-gray Sentry, with a wingspan of nearly 13 feet and weighing 280 pounds when empty, landed safely and came to its intended stop at a taxiway.

"This historic flight for Alaska is the result of the dedication of the ACUASI team and our great partners at Fairbanks International Airport, the state of Alaska's Department of Transportation and Public Facilities and the Federal Aviation Administration," ACUASI Director Cathy Cahill said. "This flight is an important first step in developing a drone economy in Alaska and improved freight and mail transport to rural Alaskans.'

Strong support from the University of Alaska, the Alaska Legislature, Gov. Mike Dunleavy and Alaska's congressional delegation made the achievement possible, Cahill said. She also said the Federal Aviation Administration's Beyond program was key to obtaining the permissions needed to fly this, and future, large drone missions for cargo

delivery and other essential Alaska missions.

"Drones have such potential in environments like Alaska. They have huge economic potential for our businesses and industries." Dunleavy said. "But perhaps more importantly they have the potential to help Alaskans when we need it the most, during disasters and emergencies such as surveilling a wildfire or dropping emergency supplies during a search and rescue."

The Sentry was treated like any other aircraft — and that's the idea behind integrating unmanned aircraft into the airspace.

The Sentry's crew, who are rated aviators, communicated with the Fairbanks airport's air traffic controllers in the same required manner as other general aviation pilots. The Sentry only moves at the airport as authorized by air traffic controllers.

The Sentry, like other aircraft operating in the controlled airspace, carries a transponder that allows air traffic controllers to know its location and altitude.

Sunday's flight was the culmination of years of preparation and coordination with airport and FAA

"Alaska is leading the way in drone research with a level of professionalism that our entire aviation community is known for," said Commissioner Ryan Anderson of the Alaska Department of Transportation and Public Facilities. "This is a professional pilot safely operating an aircraft in controlled airspace at an international airport.'

The Alaska Center for Unmanned Aircraft Systems Integration is a national leader in unmanned aircraft systems innovation and research and works with state and federal authorities to integrate unmanned aircraft systems into the national air-

The University of Alaska Fairbanks, through ACUASI, is one of seven FAA-approved test sites in the nation and the only one in Alaska.

ACUASI owns a variety of unmanned aircraft, as well as ground control stations, antennae, generators and accessories. It has the ability to deploy anywhere in the world.

The center also owns unmanned aircraft system payloads, including ground-based and airborne detectand-avoid systems, anti-GPS jamming systems, electro-optical/infrared cameras, lidars, methane detectors, aerosol samplers and more.
